

PERFORMANCE SERIES EVENTS COVID-19 EVENT RISK ASSESSMENT GUIDELINES

last updated February 2021

BACKGROUND

Shooting Australia (SA) will endorse a number of domestic events within Australia throughout the calendar year which will commonly be referred to as the Performance Series. These events will capture Pistol, Rifle, Shotgun and Fullbore disciplines with some of these events also being used as parallel Selection Events for National Team selection.

Performance Series events involve attendance from Athletes, SA Staff, Officials, Volunteers and Broadcast partners, and there will be regular occurrences throughout the domestic Performance Series that will require interstate travel by these individuals.

PURPOSE

These Covid-19 Risk Assessment Guidelines will address the steps that will be taken to determine whether the SA elements of a Performance Series event are viable to continue in their current format.

It is important to not that these are guidelines only and SA will remain flexible when making any event related decisions due to the everchanging nature of COVID-19.

PERFORMANCE SERIES EVENTS

Performance Series events will be treated differently depending on the event. Events that are run by SA which SA has the authority and responsibility for running (e.g., Wingfield Grand Prix, BISC Cup etc) will be treated differently to events that are current fixtures within another organisations event calendar (e.g., State or National Titles).

Each Performance Series event will be regularly monitored at several <u>checkpoints</u> leading into the event date and classified according to risk. The checkpoints will be at:

- 28 days
- 21 days
- 14 days
- 7 days



SHOOTING AUSTRALIA EVENTS

These are events that SA is responsible for. The following process will apply to the following Performance Series events only:

As these events are an SA responsibility, a decision on whether they will proceed as planned, in a reviewed format or cancelled lies with SA. Therefore, the following process will be undertaken to reach a final decision on the future of the event by 14 days prior to competition commencing.

As these events are not an SA responsibility, a decision on whether they will proceed as planned, in a reviewed format or cancelled does not lie with SA. Therefore, the only elements of the events that SA will make a determination on are:

- 1. Will the event remain a part of the Selection Series (if applicable)
- 2. Will the event remain an SA endorsed event and therefore considered a Performance Series event

Based on this, the following process will be undertaken to reach a final decision on these key areas.

If at any point during this process the event is postponed, SA will adopt the new date. If at any point during this process the event is cancelled, HPD and relevant National Coach/es will meet to discuss a potential replacement event, however any replacement event will not be considered a Performance Series event.

SITUATIONS OUTSIDE OF SHOOTING AUSTRALIA'S CONTROL

With the nature of COVID-19 there may be situations that arise outside of Shooting Australia's control, impacting an event with minimal notice. This document is a guideline only.

COMMUNICATION

Should there be any changes to an event, notification of such will be communicated by:

- Email
- Shooting Australia Social Media
- Shooting Australia website
- Event Hosts website and social media platforms

CONTINGENCY PLANS

While there is every intention for an event to proceed where it is viable to do so, should a decision be made to cancel an event, an alternative event format may be considered. This may in include a remote or online alternative if deemed suitable and appropriate to the affected discipline.
