2025 Officiating Scholarship Program Expression of Interest

Shooting Australia (SA) is seeking Expressions of Interest from individuals who are interested in further developing their officiating skills and experience in ISSF and WSPS.

SA will include up to 9 individuals (3 pistol, 3 rifle and 3 shotgun) in the 2025 Officiating Scholarship Program.

Expressions of Interest close on Monday 9th December. Successful candidates will be notified the week of 16th December.

To be eligible for inclusion in the 2025 Officiating Scholarship Program, you must:

- Be endorsed by the respective Member Organisation (MO) (i.e. Australian Clay Target Association, Target Rifle Australia and Target Pistol Australia) as suitable to be included in the program as a trainee ISSF Judge B and/or ISSF Referee (Shotgun)
- Be a current member of the MO for your chosen discipline
- Have completed the MO officiating course that best aligns with an officiating pathway into ISSF and WSPS
- Be able to show that you have had active involvement in officiating at events for your chosen discipline (ISSF and WSPS and/or non ISSF and WSPS)
- Have a basic understanding of ISSF and WSPS
- Have a current Working with Children Check (WWCC) or be willing to ascertain one
- Hold a current Firearms Licence
- Be willing to comply with SA's Officials and Volunteers Policies and Procedures
- Ensure you are familiar with the National Integrity Framework as adopted by SA through Sport Integrity Australia
- Be willing to complete some online Sport Integrity Australia education

As a 2025 Officiating Scholarship Program member, you will have access to:

- Mentoring from senior experienced and knowledgeable officials
- A minimum of three SA Endorsed Events to further develop your knowledge and experience (these events may include both intrastate and interstate events within your preferred discipline and SA will cover any flight, accommodation, transport and meal requirements.)

At the conclusion of the 2025 Officiating Scholarship Program, you will:

- 1. Demonstrate and display the knowledge of current ISSF and WSPS rules and protocols, including Finals Procedures across your chosen discipline.
- 2. Exhibit articulate communication skills with all involved in the Field of Play, including the Technical Delegate and Jury representatives.
- 3. Be proficient in:
 - a. Equipment and scoring mechanisms used on the range
 - b. Field of Play readiness for the commencement of competition both in qualifying and Finals
 - c. Ensuring the correct order of proceedings at the commencement of qualification and Finals
 - d. Confirming correct compliance with the applicable dress code including the display of athlete Bibs as required
 - e. Your ability to speedily and confidently deal correctly with any protests or conflict from athletes
 - f. your ability to make accurate notes of any range incident and present before a jury if required
 - g. Giving articulate and direct instructions as required
 - h. Enforcing all range safety requirements for athletes and observers
 - i. Liaising with the SA Event and Communication Manager in relation to logistics, progress and feedback through the program

ISSF Licence

At the conclusion of the 2025 Officiating Scholarship Program, if you have demonstrated key competencies, you will be enrolled in an ISSF Officiating Course to ascertain the applicable ISSF Judge B and/or ISSF Referee (Shotgun) licence.
